Condor Gold has developed an internal prevention protocol with our employees, which includes sanitary measurements within the installations and towards the surrounding communities, such as:

- Talks given and written pamphlets on sanitary measurements and COVID-19 prevention were distributed to employees.
- Avoid social gatherings as much as possible and promote social distancing in common areas.
- Use of masks for employees is obligatory in the installations and villages.
- Cleaning outside and inside of vehicles after each use.
- Alcohol spray (small) is distributed for all employees and for desk/computer cleaning.
- Benzalkonium chloride is distributed for all the employees to use in their houses to clean surfaces.
- Disinfectant booth, washing hands, shoe disinfection and thermometers are used at the entrance of the offices.
- Suppliers are met outside the office areas to reduce contact with employees.
- Guidelines for kitchen area and cleaning procedures have been modified and the use of common items has been eliminated.
- Villagers in the social programs and local schools have received talks, as well as sanitary supplies (alcohol, chlorine, etc).

As of November 2020, Condor Gold regained normal activities, all employees working full time, but with sanitary measurements and social distancing and sanitary measurements being implemented to avoid spreading of Covid-19 and ensure the safety and health of its employees and surrounding communities.

Executive summary

The following report covers the period from April to June 2021, including environment, social, health and safety and human resources areas.

Condor continues to implement its Environmental and Social Management System, which includes Environment, Community, Health and Safety and Human Resources.

Environmental work was focused on monitoring level of groundwater and surface water, monitoring climatic parameters, water management, waste management and recycling, maintenance of "Oro Verde" tree nursery and maintenance of four reforestation areas located in La India and Real de la Cruz concessions.

Participatory Water Monitoring Program was carried out, which included sampling of water quality in La India, América and Tatiana projects.

5-minute daily talks to environmental workers, support to administrative area; Environmental awareness activities were also carried out with collaborators, supporting León Zoo as part of the Biodiversity program.

Other activities included delivery of quarterly environmental reports to government institutions, advanced baseline studies in SWWB, follow-up of kinetic study for ARD, water project coordination and its environmental application process, request for harvesting of trees in Tatiana project and La India. In the same way, INAFOR led an inter-institutional commission and carried out the inspection in both areas, the corresponding payments were made to forestry services established in INAFOR's table costs. Furthermore, environmental supervision in: geotechnical drilling activities, reconfirmation and hydrology. Control and monitoring on grass burning for concessions of La India and Espinito Mendoza, these fires caused by passersby of artisanal miners.

The "Oro Verde" tree nursery has a total of 5221 plants, which are given preventive and corrective maintenance in terms of irrigation, foliar application, pest and disease control. Plant donations are made from Nursery to the community and also to institutions (such as INAFOR and municipal councils). Areas of reforestation agreements are carried out with irrigation activities, foliar application, pest and disease control, in La India concession there is a new area of 1.8 Ha, where 758 plants have been established for the rainy season.

The social area continues to work on maintaining the social license with villages neighboring the mining project through various relationship programs and communication with stakeholders.

The company's social investment has focused on social programs: Contributions and Donations, addressing issues related to education, health, sports, community mourning; during this period, 42 contributions were delivered to individuals and organizations. Agua Fresca program benefits 417 families from Santa Cruz de la India, Agua Fría villages and 26 property owners. Seniors program has 87 members; APROSAIC, that works with villages neighboring the project; Agua es Vida program, which has 180 members; Businesses program, with 77 entrepreneurs; Youth in Action program, which benefits 21 youth; and Happy Childhood, which benefits 36 children. For this quarter, focus was mainly on supporting community health on Covid-19 prevention activities.

This quarter we carried out activities that allowed us to maintain good relations with communities, generating trust and ownership with the project, such as: coronavirus prevention

campaigns and actions through all programs, starting with ourselves and thus, serving as an example to the community.

This quarter, important support was provided to the land acquisitions team to advance the Company's strategy for the purchase of properties; the Company also conducted annual meetings with all social programs, reminding its members of all the contributions and efforts made during the year.

The company continues to support training and capacity building of its employees, providing financing and scholarships for English courses, and Masters programs .

1. INTRODUCTION

This report is part of Condor Gold's commitment to continuous improvement and monitoring of the implementation of its Environmental and Social Management System (ESMS) in the areas of Environment, Social - Community Relations and Human Resources; ensuring transparency with its shareholders and relevant stakeholders.

2. OBJECTIVE

Inform stakeholders about the implementation of Environmental and Social Management System in Environment, Social - Community Relations and Human Resources areas during the Second Quarter of 2021.

3. ENVIRONMENTAL ACTIVITIES

3.1 ENVIRONMENTAL MONITORING


3.1.1 Baseline studies (Estudios de base)

Condor Gold continues to monitor groundwater level and surface water flow, as well as collecting meteorological data from its digital weather station and three rain gauges (La India, Agua Fría and La Mestiza locations).

3.1.1.1 Surface waterflow (Flujo de agua superficial)

Monitoring of landfills continues. The constant water flow is only present in San Lucas V-outlet (LIWR001).

In April and May levels were constant at 14.4 cm, however in June these fell to 14.2 cm, on average the flow during the Second Quarter of 2021 was 2.25m³ / day. Intermittent water flow was observed in the remaining weirs, showing irregular flows (pictures 3.1.1.1a-e).

3.1.1.2 Groundwater level monitoring.

Weekly monitoring continues, an average of 33 to 35 monitoring sites include geotechnical drilled wells and artisanal excavated wells.

In April, regarding the new piezometers located in the La Simona and TSF areas, eight of the 14 piezometers showed a decrease in the groundwater level between 0.03 and 0.76 m, 7 of them located in the TSF area and one in La Simona area. Four showed no change and two showed an increase between 0.02 and 0.03 m.

Regarding systematic monitoring, 7 sites showed a decrease in groundwater level between 0.06 to 1.38 m. The greatest variation was found in the hand-dug well LIWL057; therefore, variations may be due to use. One site showed no variation and another showed that the water level is at

the edge of the well. One continued to dry. Nine showed an increase in groundwater level between 0.01 and 3.08 m. The greatest variation was found in hand-dug well LIWL054.

In May, regarding to the new piezometers located in La Simona and TSF area, 10 out of 14 piezometers showed a decrease in groundwater level between 0.03 and 5.66 m. The highest variance belongs to LIGT409. 8 of them located in the TSF zone and 2 in La Simona zone. Four showed no changes.

Regarding systematic monitoring, 15 sites showed a decrease in groundwater level between 0.01 to 2 m. The greatest variation was found in the hand-dug well LIWL056; therefore, variations may be due to use. LIDC379, located in La Mestiza, did not show any variation. One continued to dry. Two showed an increase in groundwater level between 0.55 and 1.44 m. Both wells dug by hand.

In June, regarding to the new piezometers located in La Simona and TSF area, 10 out of 14 piezometers showed a decrease in water table between 0.67 and 9.53 m. The highest variance belongs to LIGT409. 8 of them located in the TSF zone and 2 in the La Simona zone. Four showed no changes.

Regarding systematic monitoring, 9 sites showed a decrease in groundwater level between 0.05 to 1.04 m. The greatest variation was found in the hand-dug well LIWL056; therefore, variations may be due to use. LIDC379, LIWL010 and LIWL059, the first one located in La Mestiza and the rest in Los Rastrojos and La India, did not show variation. One continued to dry. 7 showed an increase in the groundwater level between 0.05 and 0.73 m. in small range due to the beginning of the rainy season. With the start of the DEWATERING project, two new monitoring sites LIDC317 (India) and LIDC291 (Pozo de América)

3.1.1.3 Weather data (Datos de tiempo)

During the quarter, Condor continued to record data from the meteorological station and three rain gauges located in the Agua Fría community, the meteorological station and one in the Espinito-Mendoza concession..

In April, digital weather station recorded a total of 84.56 mm of precipitation, about 59.21 mm more than May with a total of 25.35 mm. However, in June rains increased 193.00 mm.

3.1.1.4 Site Wide Water Balance (SWWB) study

In April and May, Microsoft teams meeting of was held with consultants from SRK and TGI to further discuss hydrological model and breakdown analysis of the TSF dam. The hydraulic modeling study was sent to SRK. Design proposal was shared by CG team prior to such meeting.

Some relevant points discussed:

- Relocation of security berm can act has a black flow. However, there has been no evaluation under a dam rupture analysis.
- The open channel is large enough for flow; however, dam has not been considered.
- SRK recommends a small dam at La Simona, 3 m high and a tunnel.
- The model showed no flood risk for the village, 100-year return.
- La Simona is an attenuation pond , not for retention.
- The model is not considering a Hurricane Mitch-like event.

Next steps:

- SRK will provide data to TGI to perform dam rupture analysis with a new hydraulic model.
- SRK to provide design criteria for dam rupture analysis.
- Review of La Simona dam location, since SRK seems to have moved it 1 m.
- A 3D sound berm design is required to see who hits the dam gap, TGI obtained from DC.
- Weekly meetings will be held every Thursday.

In June, Microsoft teams meeting held with consultants from SRK and TGI to follow up on SRK's hydraulic model and flood mitigation strategy.

Some relevant points discussed:

- Drainage strategy.
- Drainage strategy option: Diversion tunnel + Small attenuation.
- Drainage strategy option: Large retention dam + Pumping system.
- Great Retention + Pumping System.
- Summarized cost (preliminary estimates).
- CAPEX and OPEX.

3.1.1.5 Acid Rock Drainage kinetic study

Continuity to the Acid Rock Drainage study for the three projects: Tatiana, La India and America, the following activities were carried out during the Second Quarter of 2021:

- In April, initial coordination was carried out with SRK -Specialist in geochemistry. Information related to the ARD static studies for Tatiana and America projects, as well as ARD kinetics study for India, Tatiana and America projects were provided to SRK. SRK sent recommendations regarding the frequency of sampling and laboratory analysis.
- In May, monitoring of water in the reactors was planned, but the lack of rain during the month prevented its execution.
- In June, two inspections were carried out after rain events, physical parameters of the quality of the water accumulated in collection barrels were measured, values obtained do not vary with respect to the last registered in the last rainy period (2020), leaks were

found and obstructions in 3 barrels, this does not allow collection of water in quantity to send the analysis sample to laboratory.

- At the end of the month water was taken to complete 5 complete samples and 1 partial of 7 total samples of the study, we contacted with laboratory for the procedure and the activity was defined for July 5th, after taking the sample, staff proceeded to repair the problem of filtration and obstruction in the reactor barrels.

3.1.1.6 Hydrogeological drilling for dehydration of the pit and possible sources of water for the mining project. DEWATERING.

Follow up on Hydrogeological Studies of La India Pit Project. DEWATERING (Drainage of underground water in the old existing galleries below the level of La India pit; underground water); as a first phase, an exploratory drilling has been carried out in the most optimal place to achieve interception from surface with the Tunel (San Lucas-Ocotillo), a hydrogeological test will be carried out in such well.

In April, hydrogeological drilling completed three alternative drilling sites, one of them located in the cooperative's area. A review was carried out based on the scope sent by SRK and workshops were held to advance study's options and objectives. A budget was made based on offers and in coordination with procurement area to acquire equipment (pump, pipes, electrical components, accessories, etc.). Several meetings were held at local level and emails were sent to discuss the progress of hydrogeological drilling to dehydrate the well.

In May, the to intercept San Lucas Tunnel was selected and quotes were discussed and shared with SRK for their due comments, with the initial proposal to drill exploratory wells and then hydrogeological drilling once it was confirmed that the Tunnel drainage had been reached. Likewise, the pumping test methodology to be implemented was reviewed.

In June, the cleaning and evaluation of sites (wells) was carried out for selection in piezometric measurements to be carried out in a hydrogeological study.

3.2 ENVIRONMENTAL MANAGEMENT.

Condor continues to implement its Environmental and Social Management System, in compliance with internal policies and international standards. Environmental Management System is given to the following activities: monitoring of groundwater and surface water levels, monitoring of climatic parameters, water management, waste management and recycling, maintenance of "Oro Verde" tree nursery, maintenance of four areas of reforestation located in La India and Real de la Cruz concessions; implementation of Participatory Water Monitoring Program that includes water quality sampling in La India, América and Tatiana projects; daily 5 minute talks with environmental workers; support to social team, project area, land acquisition area and administrative area; environmental awareness activities with a coworker, and support for the León Zoo as part of Biodiversity program.

Other activities included delivery of environmental reports of the first quarterly 2021 to government institutions, progress of baseline studies in SWWB, follow-up of the kinetic study for ARD, coordination of water project and its environmental application process, permit procedures for cutting trees in Tatiana and La India projects, environmental supervision during drilling campaign.

3.2.1 Participatory Water Monitoring Program.

In continuity with the Participatory Community Systematic Water Monitoring, that began in 2013, the First Monitoring corresponding to 2021 was carried out on April 27th. A total of 9 sites for water quality within La India Project, following the guidelines that The Company takes before COVID -19 Pandemic, community members wait on each of the sites according to the corresponding community, with participation of MEM, Mayor's Offices of El Jicaral -Santa Rosa del Peñon, MARENA-Leon could not attend.

In follow-up to baseline started in 2019 for Tatiana and America projects, samples were collected at 4 sites.

During this Second Quarter, the laboratory for technical issues had not sent results, once they have been analyzed and interpreted, dissemination material is made and dissemination is carried out in Communities prior coordination with participating institutions.

In May, a sample was taken from the new CAPS El Bordo well. CAPS temporarily installed pump and electrical system to collect a sample. The results were received and delivered to the social team, who requested this support.

Samples were carried out from the El Delirio well that supplies treatment plant. A sample was taken as effluent (water that enters the treatment system for purification) and as effluent (water already treated). The results were received on May 31st. This was done to compare results obtained by AQUATEC during their tests.

In June, laboratory results of the sampling carried out in April 2021 were received, the data was entered into LIGSA System to proceed with the dissemination material for the villages, prior coordination with the institutions.

3.2.2 Waste management program implementation.

During this Second Quarter, activities related to waste management continue in La India, Espinito Mendoza, Cacao concession and internal facilities

A total of 240 lb of waste from Santa Cruz de la India, validated by Santa Rosa del Peñon Mayor's Office, and 180 lb of organic waste were generated and sent to community dump; 60 pounds were stored for recycling, the latter being temporarily stored in ALPHA 3.

New metal containers were built to replace the old ones in public places: outside alpha 1, information office, alpha 3, at La Mestiza security post and two in alpha 6.

47 pounds of disused office paper were delivered to Los Pipitos NGO.

During Morning Talk, internal Waste Management Manual is reviewed.

Agreements are being carried out with Santa Rosa del Peñon municipality for the allocation of a new area that will be used as a Communal Dump (Santa Cruz de la India and neighboring communities) to deposit household waste. Field visits were executed in accompaniment of MARENA-Leon and the Santa Rosa del Peñon Mayor's Office-Environmental Unit, for the next quarter information on the achievements carried out will be provided.

3.2.3 Soil protection and biodiversity conservation.

Following the guidelines in the Internal Soil and Biodiversity Management Procedures, the following activities were carried out:

Donation of food-seeds for birds to the ArlenSiu Zoo located in the department of Leon.

Maintenance of Reforestation areas in La India Council continues as part of the compensation commitments for La India Exploration Project and Real De La Cruz Exploration Project permit.

Inspection of drilling sites directly to contractors (Rodio Swwisboring and Kluane) to guarantee compliance with environmental, security and social guidelines established in the service contract (La India, Cacao and Espinito Mendoza concessions).

Environmental activities in coordination with the social area, for this quarter in Cacao, 2 activities were carried out, one focused on cleaning water sources and the other on reforestation of water sources.

During April, fire prevention-control and extinction activities were carried out. The fire control brigade covered a total of 6 fires. All were under control before they could spread and did not cover large tracts of land. Everything less than 1 Ha.

Approximately 0.5 Ha were affected on the LIISA property, before Martín Rivera. Two fires were put out in the plant and storage area on the LIISA property. Another fire was controlled within the alpha 6 property with the José León Vega boundary. Another fire was the control on the property of LIISA, before José Díaz on the way to La Mestiza.



3.2.4 Tree Nursery “Oro Verde”.

The Oro Verde Nursery is the model - productive area of forestry, ornamentals, medicinal plants that has served as an example and education-awareness to collaborators and communities; and where plants are produced for reforestation agreements in compliance with the requirements in reforestation of the region. Environmental permits for mining concessions La India, Real de La Cruz, Cacao. In the same way, produced plants are donated to state institutions such as INAFOR and municipalities.

Currently there are 5221 plants, where preventive-corrective management is given in nutrition, pest and disease control.



Collaborators have been trained in the application and handling of natural products -Biogrin.



3.2.5 Implementation of reforestation plans and activities.


3.2.5.1 La India concession – reforestation activities

Maintenance of reforestation areas continues as a commitment to Compensation Plan for the Environmental Permit of La India Exploration Project, executing reforestation agreements in Nance Dulce, Los Rastrojos and within the company's ALPHA 6 property. Maintenance is necessary to ensure the survival of planted trees and is part of company's environmental commitments in La India environmental permit.

Activities in reforestation areas included cleaning, fertilization, irrigation, pest control, formation pruning, and sanitation. A new area was acquired under a reforestation agreement for a total of 1.8 Ha, where a total of 758 forest plants have been established until June.

3.2.5.2 Real de la Cruz concession – reforestation activities

In correspondence with Reforestation Plan for Real de la Cruz Exploration Project, maintenance in the reforestation areas under agreement continues, in terms of irrigation, application of foliar, cleaning, control of pests and diseases, repair of fences.

A sign was placed to identify areas under the agreement, it is important to mention that these signs are made by our environmental staff.

3.2.6 Procedures for tree cutting permits with INAFOR.

Tree harvesting process for Tajo La India and Tajo Tataiana Project began, the documentation requested by INAFOR (National Forest Institute) was sent. In the case of La India Pit Project, two requests were made due to the fact that this project is located in two municipalities. Plant infrastructure, warehouse, powder magazine, rainwater dam, internal roads, pits, dumps of sterile material) for the municipality of Santa Rosa del Peñon and for the municipality of El Jicaral corresponds the tails dam.

In July, inter-institutional commission chaired by INAFOR carried out a field inspection to validate information contained in forest inventory regarding sampling plots, species, diameters, Heights. Participating National Police, MARENA (Ministry of the Environment and Natural Resources, INAFOR, the technical monitoring unit and Mayor's Offices of Santa Rosa del Peñon and El Jicaral respective environmental Unit.

By the end of June, there were already payments for pre and post inspection, payment for harvesting, and payment for repositioning forest resource to be affected, as established in Contract for Repositioning the resource. For July, INAFOR will be delivering full permits.

3.2.7 Internal support to the areas.

For this Second Quarter of 2021, environmental area provided support to internal areas when required in order to meet development objectives of the company, these are:

In the Cacao concession, the geology area was supported in closure of platforms in three mud pits in drilling area of Cacao concession.

Support for the acquisition of land in the identification of potential areas for a water well to supply water to Orozco family.

The administration area was supported to find a new provider for the cleaning of septic tanks that is authorized by MARENA and in the installation of a sign of "Do not litter" outside Alpha 3 area, an area that the community often use as a illegal garbage dump since it is closed to La Simona creek.

3.2.8 Environmental Monitoring of Contractors in Drilling.

During the second quarter of 2021, the inspections continue for Cacao Council focused on drilling Contractor with Kluane and Rodio Swissboring for La India and Espinito Mendoza concession, observations were given to fulfill environmental guidelines acquired during contracting of the service;

- Water Management (Amount of fresh water used, recirculation and water management)
- Waste management (according to internal classification)
- Hydrocarbon waste management
- Order - Cleaning
- Labeling
- Environmental talks
- Hydrocarbon consumption (oils, fuels, grease)
- Ambinetal incidents

The findings of non-conformities are sent to the environmental units of each contractor as well as to the geology area..





3.2.8.1 Platform remediation

For this Second Quarter of 2021, remediation of drilling platforms in Cacao concession began. Likewise, fruit plants were delivered to land owners as part of remediation commitment.



4.2.1.1 Santa Cruz of La India community

During the second quarter of the year 2021; From April to June, Agua Fresca program launched the first stage of the improvement of the Santa Cruz de La India's water system, with the installation of the water purification plant located in Finca "El Delirio", in this quarter the house-to-house delivery was resumed and the benefit was increased to two canister weekly. As of June, the water produced by the "Agua Fresca" program began to be distributed and the delivery of four free canisters and four subsidized canisters monthly, directly benefiting 417 households in Santa Cruz de la India communities and Agua Fría, these communities are directly affected by the Mina La India project.

Support was also provided to vulnerable sectors: Seniors, people with different abilities and multi-household families through the free delivery of the eight canisters monthly. With this, it supports the reduction of water shortages and intestinal diseases, providing residents quality water for their consumption.

In May, house-to-house delivery of water canister was resumed and water purification plant was inaugurated at "El Delirio" farm, in June the benefit was doubled, giving beneficiaries two canisters weekly, one delivered house to house and the second in a central point of the community (Condor Gold Information Office) on Wednesdays from 9: 00- 12:00 noon.

In the Santa Cruz de La India, 3,578 canisters of fresh water have been delivered between April and June.

Activities within the water program:

- 275 families have the benefit of receiving two canisters of water weekly. Profit that doubled, before it was one jug a week.
- 275 families received recommendations on cleaning bottle and dispenser to prevent virus infections.
- 275 families received recommendations on proper care and use of canister.
- 5 institutions received two canisters of water weekly, 4 of them for free.
- Dispensers were delivered to new beneficiaries enrolled in the program.

- Delivery of the quarterly magazine "La Voz de La India" to beneficiaries of Agua Fresca program in Santa Cruz de La India.
- Delivery of present to mothers of the program for their celebration.
- Presentation of Agua Fresca team to beneficiaries from Santa Cruz de La India.

4.2.1.2 Agua Fría community

The fresh water program reaches every home in Agua Fría, also permanently benefiting families where there are seniors and people with disabilities.

With the inauguration and start-up of the water purification plant, purified water began to be distributed and with this new benefits for families of the village, such as the registration of multi-household families in the program. Initially, multi-household will be incorporated so that all the families in the village will receive this benefit, upon enrollment of all families, the delivery of two canisters a week will begin.

1,330 canisters have been delivered during the second quarter of 2021.

Activities within the program:

- 142 families receive their canister weekly
- 142 families received recommendations on cleaning bottle and dispenser for virus prevention.
- 1 institution receives canister weekly for free.
- Water delivery house to house

- Registration of multihome families in the Agua Fría community (4 registrations)
- Information was given on preventive measures against Coronavirus during canister delivery through flyers and delivery of a prevention kit against pandemic.
- Delivery of quarterly magazine "La Voz de La India" to beneficiaries of Agua Fresca program.

4.3 IDENTIFICATION OF VULNERABLE FAMILIES

4.3.1 Santa Cruz de la India's Seniors Program

During the 2nd quarter of 2021 and taking into account hygiene and prevention measures due to Coronavirus, program's activities were carried out with a house-to-house methodology and meetings were resumed to share group activities, always in compliance with hygiene and prevention measures indicated by the WHO.

During the quarter, 36 food packages were delivered, 51 health kits, 51 files of active members in the program were updated, and 100 seniors, including those who are not registered, saw a video promoting a healthy lifestyle.

As part of the activities carried out by the Board members, identity cards were processed and municipal actors- such as mayors and priests- were visited to inform about the activities executed during the 2nd quarter.

Within the recreational activities, occupational therapy was carried out, which consisted of painting handicrafts in clay with watercolor and celebrating Mother's Day with members of the Piñatas project.

Health is one of the main axes of the program and most of the activities were focused on improving the life quality of seniors. The phase of physiotherapy evaluations began with the purpose of designing a dance therapy program and physical therapy that benefits seniors.

We closed the 3rd quarter with 87 registered members, 1 member died and 2 left the community.

The self-sustaining Projects Medicinal Garden and Piñatas, worked actively during the quarter and the conditioning of a new area has begun to move the medicinal garden.

4.4 TATIANA AND AMERICA PROJECT.

In the II Quarter of 2021, Condor Gold has strengthened direct relationship with indirect impact villages of América and Tatiana secondary projects: El Tanque, Talpetate, El Capulín and Quebrachal.

These communities have been of interest to the company since it plans to develop two secondary mining projects located in the area of San Juan and La Mestiza: América and Tatiana; These communities are “relatively” closest to this execution zone.

Social work’s alignments are activities in health, education, environment and community leadership to contribute to inhabitants’ quality of life and participation.

Cóndor Gold has worked hand in hand with Santa Rosa del Peñón Mayor's Office, community leaders and residents where they have joined efforts to fix the road to Tanque and Talpetate villages. The road has been one of the greater needs that these communities have requested and today they are joining efforts so that inhabitants have accessibility.

Due to the pandemic, community social work continues to focus on health, hygiene and activities have been carried out maintaining a constant relationship with community leaders.

During the quarter, activities focused on supporting the repair of schools were carried out, such as the repair of the electrical system from Andrés Castro school in Tanque, celebration of The

week of Children & Environment and fundraising with parents to purchase items for the school repair.

Health conferences were held for inhabitants, remembering to take care of vulnerable groups such as seniors during pandemic; a talk was given to children from Tanque and Talpetate about medicinal plants as an alternative to improve health.

A constant relationship was maintained with community leaders and residents to coordinate repair of the road, which was a success; the inauguration was held with local actors such as the Mayor from Santa Rosa del Peñón and Political Secretary.

Social management in these communities has contributed to residents having a better relationship, thus knowing their concerns and doubts about the projects and company's work; in this way, to be able to give answers and / or be a bridge to seek solutions and clarify doubts.
